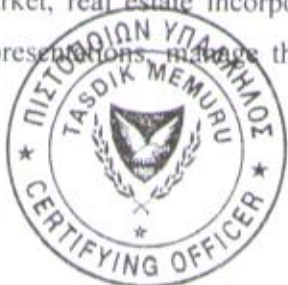
**POWER OF ATTORNEY**

In view of international legislation regarding combating the movement of the proceeds of crime, any action undertaken through the use of this document must comply with the Articles of Association of the Company (or the relevant rules applicable to the entity) as well as the applicable laws of the country where the entity is registered or where the officers of the company reside. The Attorney making use of this document will carry out effective consultation with the Board of Management.
