

**Re: Gater Assets Limited v. AO Gazsnabtranzit, et al., 2016 Civ. 4118 (S.D.N.Y)**


Gater Assets Ltd. (“Gater Assets”), through its undersigned counsel, writes to respectfully request that the Ministry of Justice (“Ministry”) assist Gater Assets in serving judicial documents under the Hague Convention for Service Abroad of Judicial and Extrajudicial Documents (“Hague Convention”).

On June 6, 2016, Gater Assets sent the Ministry three requests for service in connection with a court case filed in the United States District Court, Southern District of New York: *Gater Assets Limited v. AO Gazsnabtranzit, et al., 2016 Civ. 4116 (S.D.N.Y.)*. The requests for service sought the Ministry’s assistance in serving AO Gazsnabtranzit, AO Moldovagaz, and the Republic of Moldova with the following court documents: (1) a Summons, (2) the Complaint in Action for Renewal Judgment and Exhibits thereto; (3) a Civil Cover Sheet; (4) a Related Case Statement, and (5) a Corporate Disclosure Statement (together, the “Service Documents”). Gater Assets’ requests for service complied with Article 5 of the Hague Convention. Gater Assets also requested that the Ministry return of a certificate certifying that service had been made in accord with Article 6 of the Hague Convention.

Though Gater Assets’ records show that the Service Documents arrived at the Ministry on June 9, 2016, Gater Assets has not received any certificate as to service. As such, it appears that service has not yet been made.

As such, Gater Assets again respectfully requests that the Ministry serve the Service Documents. To further assist the Ministry in its efforts, enclosed are courtesy copies of the original service requests and the Service Documents, as they were sent on June 6, 2016, as well as translated versions of the same in Romanian, Moldova’s official language.
